Dear Exhibitor,

Each booth will be 8' deep x 8' wide, and will include the following.

- A. 8' high back wall of draping material
- B. 3' high side walls of draping material.
- C. (1) 7" x 44" exhibitor identification sign.
- D. (1) 6ft. skirted display table
- E. (2) chairs
- F. (1) wastebasket with liner

Electric service (110v-dual receptacle 1-5amps) if required, should be ordered in advance to insure availability. See Rental Equipment form. If your exhibit requires 6-20 amps of service you, will need to order a 20amp direct line.

All exhibit material must be directed to the address shown on our shipping forms. The Lodge of Four Seasons does not have facilities for storage of exhibit material. We need the Exhibit Material Handling form on file at our office, before the arrival of your freight. Shipments that we receive will be delivered to your booth prior to exhibitor set-up. Prior to the close of the show we will discuss with you your outgoing shipping arrangements.

Note - the Granada Ballroom is carpeted, and has complimentary Wi-Fi.

A service desk will be maintained during exhibitor move in to answer any questions and to provide you with additional booth furnishings that might be required.

- When time frame allows, we request that pick ups be scheduled at our warehouse, the next business day after show closes.
